

## STYLE SHEET AND GUIDE TO AUTHORS

**NOEMA** is an annual trans-disciplinary journal of the Romanian Academy. Its themes and topics must be correspondent to the ends of Romanian Academy's Committee of History and Philosophy of Science and Technology (Comitetul Român de Istorie și Filosofie a Științei și Tehnicii – CRIFST). Its articles are peer reviewed on a double-blind basis by two reviewers prior to acceptance for publication.

### **General Points**

The texts proposed for publication must be previously unpublished in that language.

The technical terms have to be explained. If technical details cannot be avoided, they will be included in annexes, leaving the text accessible to the non-specialist reader. However, in those cases in which formalization is compulsory, it may be included within the text but must be accompanied with clear interpretations and examples.

Papers will be presented in Romanian or English / French. They will be edited with MS Word '97 version at least, A5, in single spacing, justified, font Times New Roman at 10 points. Diacritics are obligatory in Romanian texts. 150 words Abstract as well as Keywords, in English, and also the affiliation and current position of the author (possibly his last published book) should accompany each submission. Papers will not exceed 6,000 words (including annexes and bibliography). A longer work could be allowed only exceptionally.

### **Text**

The authors are required to write the texts conformingly the following norms:

- Indentation of paragraphs.
- Chapter titles.
- Quotations: a) If the quotation is less than 3 lines long, it can be given in the text; b) If the quotation is more than 3–4 lines long,

it is indicated apart with paragraph indent left and right and spacing before and after.

- References in the footnotes (please use footnotes only), font Times New Roman at 10 points.

- Capitals should be used sparingly. Use italics for non-naturalized words of foreign origin. Thus: *Weltanschauung*.

- Omit full stops from common abbreviations and acronyms: MP, USA.

## References

Footnotes may be used for both comments and references. The authors' name mentioned in the footnotes has the common order where the first name precedes the last one.

A list of References/Bibliography should be added at the end of the paper, according to the alphabetical order of authors' last name.

It is not allowed to insert in the final list of References works that were not quoted or referred to within the paper.
